Last year, due to your generosity, we raised a total of \$1,785,298. This allowed The Woman's Board to fund renowned clinical programs and leading-edge research while providing comprehensive social service and community outreach programs for patients across the Midwest.

Your support enabled The Woman's Board to fulfill its \$450,000 pledge to expand the Rush Education and Career Hub, or REACH. This workforce development program provides mentorships, job shadowing and internships to high school and college students, preparing them for success in the health care industry.

### **Sustain Unparalleled Care — Patient Assistance (13%)**

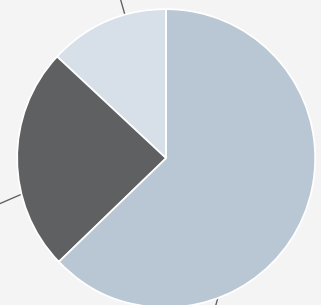
